Travel Permission Slip and Deposit Policy

- To be eligible to travel for each regatta and boat selection eligibility by the coach, all interested athletes must provide a **permission slip with deposit (no cash) by deposit due date** indicated below to the Booster Treasurer for each regatta (faxes cannot be accepted).
- All deposits are **non-refundable**. Deposits for athlete(s) not selected for a **select crew** regatta are the only exception.
- All athletes are responsible for the **full** amount of the trip once they have submitted their deposit. There are no exceptions.
- Coaches cannot accept permission slips and deposits for athletes.
- Athletes with any outstanding club balance will not be eligible to travel.

Consequences of Late Permission Slip/Deposits

- Late permission slips or deposits will incur a **\$50 late fee**; the Head Coach and or Board of Directors may waive fee for extenuating circumstances (should they apply).
- Late permission slip/deposits for Athlete's participation will be at the discretion of the Head Coach along with Board approval.
